Village Administrator Stumpf updated the Board concerning the new snow plow vehicle. Extensive discussion amongst Board members concerning the purchase of a new snow plow vehicle. VILLAGE ADMINISTRATOR'S REPORT:

Village Administrator Stumpf reported the Village has had on-going problems with the Orchard lift station. Village Administrator Stumpf updated the Board concerning Cellular telephonic systems for the sewers. President Clark suggested we draft a tactful and respectful letter concerning the on-going problems with the pumps and what not to put into the sewer.
