DISCUSSION AND POSSIBLE ACTION RELATED TO VILLAGE ORDINANCE 1.13 AND OTHER SUPPLEMENTS RELATED TO PUBLIC RECORDS: Attorney de la Mora reviewed the recommended changes to the existing ordinance. After discussion, possible

action on the changes was tabled until the June meeting to allow the trustees to further review Ord. 1.13 and the proposed amendments thereto.

PARTICIPATION IN THE MEETING AFTER THE PERIOD FOR PUBLIC COMMENTS: President Clark reviewed the policies and procedures used by the City of Oconomowoc and the Town of Oconomowoc related to public comments and participation from the floor after the period for comments has closed.

Beginning in June, those wishing to make a comment will be required to fill out a card with their name, address, and issue to be discussed. Comments will be limited to a single topic and to a period of three minutes. The village president will call the resident forward to make the comment. Citizen submitted written comments will not be read into the record data by a member of the board during the public comment period. Residents are encouraged to contact members of the board with any issues or concerns; the board members can request that an item be added to a future agenda.

Limited participation by residents in discussions after the period for public comment will continue to be allowed.

REVIEW A DRAFT OF A SURVEY RELATED TO POSSIBLE USES FOR THE DOT LAND: President Clark presented a draft of a cover letter and survey related to the DOT land. Trustees Stormo and Koenigs requested that additional financial information be included related to the costs and benefits of the possible options. Trustee Koenigs requested that the location of the two parcels purchased from the DOT be identified as "Saeger East" and "Saeger West" and maps of the two locations be provided. Modification to the draft will be reviewed at the June meeting.

VILLAGE ADMINISTRATOR'S REPORT:

Village Administrator Stumpf reported the Village has had on-going problems with the Orchard lift station. Village Administrator Stumpf updated the Board concerning Cellular telephonic systems for data pertaining to the sewers.
